The Hall of Fame honors those bowlers who through their competitive skills, high personal standards and dedicated principles, have enriched the general welfare, spirit, reputation and progress of the sport of bowling.

Nomination forms are available through the Cecil Harford USBC Association web site([www.chusbc.org](http://www.chusbc.org)) or at any local bowling center for any member to have the opportunity to submit nominations for the Hall of Fame. The sponsor of a nominee should provide sufficient information. All nominations must be turned into the Cecil Harford USBC Association, no later than November 30<sup>th</sup> of each year. Nominations received after November 30, will be considered for the following year

The committee to elect the Hall of Fame nominee will consist of all Hall of Fame members and current Cecil Harford USBC Association board members. Ten (10) voting members must be present to vote. No proxy votes will be accepted.

To be eligible for election to the Hall of Fame in the **Superior Performance** category a candidate must be or have been:

1. A member of the Cecil Harford USBC Association for at least twenty (20) years as of August 1 of the year of nomination
2. Member must have a Cecil Harford USBC yearbook average of thirty-six (36) or more games per year as of August 1 of the year of nomination
3. Member must be forty (40) years of age as of August 1 of the year of nomination
4. Nominee must hold at least ten (10) USBC Adult certified scratch bowling titles, with at least two (2) of which must be singles titles, earned while a member of the Cecil Harford USBC Association

As a member of the Cecil Harford USBC Association, they have represented the association when earning these scratch titles

Team, Doubles, Singles, All events, the titles could include but are not limited to: Cecil Harford USBC Association titles, Cecil Harford USBC Association Seven Hundred (700) Club titles, Mixed Cecil Harford USBC Association titles, other Association titles, State Association titles, National or Professional titles, etc.
